The Council of the Slovenian Quality Assurance Agency for Higher Education adopted the following decision at its 92nd session on the 18th June 2015 based on the seventh indent of the Para 11, Art. 51. h and Para 7, Art. 51. r of Higher Education Act (Official Gazette RS, Official Gazette RS, No. 31/2012 – official consolidated text seven) relating to the joint process of reaccreditation of AMEU ECM and higher education study programmes of the first cycle of “Physiotherapy” and “Nursing”, initiated on the request of AMEU ECM, represented by professor Ludvik Toplak, PhD:

DECISION

1. The Council of the Slovenian Agency gives AMEU ECM reaccreditation for the Institution of Higher Education and for the professional higher education first cycle study programme “Physiotherapy” and higher education first cycle study programme “Nursing” for seven years.
2. The costs incurred in these proceedings shall be borne by the Agency.

Explanation:

On 30th September 2014, AMEU ECM, Slovenska cesta 17, 2000 Maribor (hereinafter referred to as: the applicant) submitted the application for the reaccreditation of the professional higher education first cycle study programme “Physiotherapy” and the professional higher education first cycle study programme “Nursing”.

The study programmes in question are professional higher education programmes of the first level, they last 3 years and are evaluated with 180 ECTS. The institute headquarters are located in Slovenska ulica 17, 2000 Maribor, but the study programmes Physiotherapy and Nursing are carried out at the location Lendavska cesta 9, 9000 Murska Sobota.

Nursing. Refers to the higher education first cycle 3-year study programme evaluated with 180 ECTS. According to the ISCED Classification, the study programme is classified within the code 72: Health Care. This study programme does not include majors or modules. According to the KLASIUS-P Classification, it is classified under the code 7231 (health care); it is part of medical sciences according to the Frascati Classification. The professional title of the graduate is Registered Nurse, abbreviated R.N.

The 3-year study programme **Physiotherapy** is classified within the code 72: Health Care according to the ISCED Classification. This study programme does not include majors or modules. According to the KLASIUS-P Classification, it is classified under the code 7261; it is part of medical sciences according

to the Frascati Classification. The professional title of the graduate is Bachelor of Physiotherapy, abbreviated BA Physiotherapist.

Legal instruction:

An appeal shall be allowed against this decision within 30 days after the delivery of a copy of this decision. An appeal can be submitted to the public body that issued the decision, namely the Council of the Slovenian Quality Assurance Agency for Higher Education, Slovenska cesta 9, 1000 Ljubljana. The appeal must indicate the decision that is called in question and must contain the number and date of the decision subject to the appeal and the name of the public body that issued the decision. The appellant must indicate why the decision is called in question (Article 238 of the General Administrative Procedure Act). The Appeal Commission of the Slovenian Quality Assurance Agency for Higher Education will decide on the appeal.
